

Athabasca Denesųliné Agreement

(North of 60 Agreement)

NOTICE OF APPLICATION TO VOTE

TAKE NOTICE THAT a vote will be held from May 21, 2025 to June 27, 2025 to ratify the:

- (1) Athabasca Denesųliné Agreement between Black Lake First Nation, Fond du Lac First Nation and Hatchet Lake First Nation and the Government of Canada; and
- (2) the Denénjh Néné Legacy Agreement.

AND FURTHER TAKE NOTICE THAT an individual will be eligible to vote in the Ratification Vote if that individual has submitted a completed Voter Application to the Ratification Committee and is at least eighteen (18) years of age on or before the day you vote and:

- (a) is, or is entitled to be, on the Band List of Black Lake First Nation, Fond du Lac First Nation or Hatchet Lake First Nation;
- (b) was adopted as a child under laws recognized in Canada or under Denesųliné custom, by an individual who is, or is entitled to be, on the Band List of Black Lake First Nation, Fond du Lac First Nation or Hatchet Lake First Nation;
- (c) is a descendant of a person described in (a) or (b); or
- (d) is a descendant of a Denesųliné individual who was on the band list of the:
 - (i) Maurice Band at the adhesion to Treaty 8 on July 23, 1899; or
 - (ii) Lac La Hache Band at the signing of Treaty 10 on August 22, 1907; and

AND FURTHER TAKE NOTICE THAT an individual will not be eligible to vote in the Ratification Vote if that individual is:

- (a) on a Band List other than the Band List for Black Lake First Nation, Fond du Lac First Nation or Hatchet Lake First Nation; or
- (b) enrolled under another Land Claims Agreement or self-government agreement.

AND FURTHER TAKE NOTICE THAT an individual may access the Voter Application online at www.nuhenene.ca, or request a digital or physical copy from the Ratification Committee at the contact information listed below;

AND FURTHER TAKE NOTICE THAT only individuals who have submitted a completed Voter Application to the Ratification Committee on or before January 27, 2025 and have been determined to be eligible may vote in the Ratification Vote; however, individuals on the Band

List of Black Lake First Nation, Fond du Lac First Nation and Hatchet Lake First Nation may submit a completed Voter Application to the Ratification Committee up to and including the Voting Day;

AND FURTHER TAKE NOTICE THAT the Ratification Committee will publish a Preliminary Voters List, and procedures for making an appeal of the Preliminary Voters List, by February 19, 2025 and will publish a final Voters List, by May 13, 2025;

AND FURTHER TAKE NOTICE THAT a Voter or Members on the Band List of Black Lake First Nation, Fond du Lac First Nation and Hatchet Lake First Nation may request a copy of the Athabasca Denesųliné Agreement and Legacy Agreement, which are confidential and for Members and eligible voters only, by contacting the Ratification Officer at the contact information listed below;
